REVIEW FINANCIAL REPORTS AND VESTRY APPROVED 2023 OPERATING BUDGET

High level comments on results of Budget for Fiscal 22 and Projections for Fiscal 23 by Treasurer, Dick Ingram.

"Had some, Got some, Spent some, Still have some."

- CCE has \$236,000 in cash in the bank. Roughly \$60,000 from parishioners who have prepaid their pledges for 2023.
- CCE has \$120,000 set aside in a reserve account. We also have separate accounts for PSP, Rector's discretionary fund and one other small fund.
- · Expenses came in under budget
- We also have an endowment of roughly \$3M. Our contributions from the endowment will drop slightly this year. Our funds did fairly well experiencing only a 3% drop. The endowment distribution rate is designed to maintain the principal and to provide some consistent income throughout the year.
- · Took out small loan to pay for repairs to skylight
- · Included a line item to set moneys aside in order to build a reserve over time for funds to be drawn on to maintain the building and make inevitable repairs, such as boiler/furnace maintenance, etc.

Questions from the parish:

- · Is there a limit on withdrawals from endowment annually? Not strictly, no.
- Why didn't we draw from the endowment to pay the loan for B&G skylight? Terms of the loan were so favorable that it made more sense to protect the endowment and pay over the life of the loan.
- Do we have anything invested in the stock market? The Endowment fund is a balanced fund between stocks and bonds, managed by BOA. Our endowment funds decreased but came back to where they had been.
- · Parishioners expressed appreciation for setting funds aside for building maintenance.

In summary: CCE is maintaining expenses with caution and frugality; we are also protecting strong financial resources we do have.

The congregation received the reports and the 2023 budget as presented in the Annual report.

CLOSING PRAYER: Mark Pendleton offered a closing prayer.

ADJOURNMENT: It was moved and seconded that the meeting be adjourned. The meeting was adjourned at 12:06pm.

2023 Rector's Report

This past year the vestry and staff spent much of 2023 doing what we did in 2022, mainly re-gathering our community. We prioritized Sunday worship and finding opportunities to get people back face to face.

We introduced a new website in June as well as a new format for our weekly eNews that is sent out each Friday morning. We have roughly 500 contacts in our email roster, and each week about 300 of these open up our eNews.

We introduced a new platform for donation online which we have found much easier to navigate vs. the version we used in past years. Consider signing up for direct payments, which are a godsend for churches as we cover payroll and other expenses through the year.

2023 saw a deepening and strengthening of our unique collaboration and support with our Pine Street Players youth theatre program and ministry. This program impacts hundreds of children and teens in our local and extended community, offering a space to learn and grow. We have put our faith in a kind of youth program that gathers and transforms even as God is not explicitly named but we believe very much present.

Families with children of school age were greatly impacted by the Pandemic. Sunday routines were disrupted, and quite honestly it has not been easy to return to past levels of participation. Regardless of how many children and teens come for faith formation, we are present with them as we live out our baptismal vows to support them in their life in Christ.

We honored the Rev. David Holroyd on October 1 with a retirement reception that celebrated a 14-year long ministry with us. David continues to worship with us on most Sunday mornings from the pew and is always ready and able to pitch-hit for clergy when needed – yes another parting baseball reference! What a true colleague and friend David has been and continues to be to me and a trusted fellow pilgrim for all of us.

In November we wished Godspeed to the Rev. Melissa Remington who worked with us for two years. Melissa was a regular presider and preacher at worship and truly held our Sunday School program together during the last phases of Covid.

My wife Leslie and I hosted two gatherings of new members at our home in Greenland. These information gatherings are key moments that help new folks meet others in a more relaxed setting. When people ask me what it takes to be a member of Christ Church, I say: "Do you come, do you care, and do you give something of yourself. The paperwork we can work out."

A continued blessing is our monthly Men's Group. We gather between ten to fifteen men to provide space and time for sharing, fellowship, and learning.

I continue my work at the Stafford County jail in Dover, serving on their Spiritual Life Committee. I make visits two times a month as part of the New Hampshire Immigrant

Visitation Team, meeting ICE detainees, many of whom speak Spanish, who are awaiting asylum hearings and deportation. It is humbling work that can seem hopeless at times as the mood in the country is not one that is extremely open to addressing the human suffering of so many around the world. I will often say to those interested in this work that I personally do not believe in so-called "open borders," but I have seen the human impact of our broken immigration system that in my view can only be solved by legislative action in Congress.

At the risk of failing to mention some folks, I do wish to recognize the following persons:

- ❖ Outgoing Members of the Vestry: Lauri Ayers and Chris Sera rotate off of vestry at this Annual Meeting. Thank you for your dedication and faithfulness. Lauri brought her voice to our work and Chris was a dedicated member of our Buildings & Grounds Committee that does so much behind the scenes to keep our ministry open and operating. Well done!
- ❖ Richard Ingram, our elected Treasurer came on board as our paid Bookkeeper in November with the immediate task to review our financial systems and fix outstanding issues. He has been invaluable with being a liaison and supporter of our Pine Street Players.
- ❖ Our Streaming Tech volunteers: It is now a given that every Sunday service is live streamed to our YouTube channel. We could not offer this ministry without the dedication of Joe DiPalermo, Leslie Pendleton, and Will Sera.
- Members of the Altar Guild are always the unheralded worker bees behind the scenes who demonstrate such care and commitment to ensuring that all is in place for worship. Sue Ingram has managed the team with grace, and they all stepped up to help her this past year.
- ❖ If we had an honorary member of the staff it would be **Joe DiPalermo**. He is the face and force behind the scenes who books outside groups and opens and closes for them, he is an indispensable piece of our Pine Street Players community, and is always on the other end of the phone willing to do almost anything when called upon. And Joe would be the first to admit that his wife **Diane** is always at his side.
- ❖ At the Close of 2023 Members of the church staff: Darla Watt, Bruce Adami, Suzanne Jones, George Malgeri, Richard Ingram and Lexi Meunier. The staff of any church is fundamental in carrying out the work we have been given by the leadership. We have been fortunate to have the people we have making so much of what we do possible.

CHRISTIAN FORMATION

The Rev. Melissa Remington coordinated our Sunday School offerings for 2023. We have committed to offer lectionary based Sunday School lessons in the downstairs classrooms for ages 5-12. 13-14 is the typical age for Confirmation. Attendance is as consistent as we would hope, as we have struggled like other churches to draw families back after the Pandemic. Our lead teacher was Katherine Gibson, without whose support we could not offer what we do each week.

The Rector and John Cofer prepared 12 young persons for Confirmation. Bishop Hirschfeld visited Christ Church on May 7. A series of adult Inquirers' Classes were also held by Zoom, which allowed for deeper knowledge of the Episcopal Church and prepared 3 adults to also be confirmed by the bishop.

In the fall of 2023, the Rector offered eight Monday evenings on Zoom to continue watching and discussing Season 3 of the streaming series The Chosen.

Senior & Junior Wardens - Annual Report 2023

Beginning in 2022 and continuing through 2023, the focus of the Vestry has been to regather, reconnect, and affirm our connection both in worship and community-building post-Covid. The "new normal" as we called it has resulted in a gradual increase in face-to-face community gathering as evidenced by increased attendance in worship services, a consistent increase in participants in our Adult Forum Series, as well as robust attendance in many of our small group gatherings including Bible Study, the Men's Group, and Oasis Sisters.

A shining example of our re-gathering this year was Christmas Eve 2023. Both services, the 4:00 Pageant and the 8:00 Liturgy (filled with awe inspiring music), brought both regulars and many new attendees into the sanctuary for worship. This was such an encouraging sign of hope compared to the Christmas Eve services during Covid. As you all may recall, the Pageant had to be held outdoors, and we were only allowed to walk through the sanctuary wearing masks as a substitute for the Christmas Eve liturgies in 2020 and 2021.

In celebration of the return of life-giving vitality to the church this Christmas, a shout-out goes to the volunteers from The Pine Street Players who filled the Christmas Eve choir with young voices and faces, as well as a shout out to many of our gifted parishioners who joined the choir to fill the hall with world-class sound. Thanks go to Suzanne Jalbert Jones and Bruce Adami for their inspiring leadership in "all things music", both during the Christmas services as well as all throughout the year. And a very special shout-out goes to our own David Holroyd for rocking out during the gospel number at the 8:00 service. What a joyful sight to see!

Another positive sign of re-gathering in community can be seen through the efforts during coffee hour. Volunteers, coordinated by Jen Murray and Kim Billings, include efforts from Adrienne Spear, Mary Webber, Jeannette McDonald, Ann Junkin, Toy Fountain, Linzee Coleman Bagge, Kim Billings, Suzanne Fong, and Jen Murray. Each Sunday, their efforts not only created a place for people to connect socially, their efforts also provided welcome sustenance and the gift of hospitality for those who stayed for the Adult Forum sessions. In addition, Kim Billings makes sure that goodies are sent off in the van for the folks from River Woods to take back with them.

The Adult Forum Series continues to grow and thrive during this past year, as we consistently gain new attendees. During this year's "Red Door Series", the attendance at each forum has averaged between 30-45 people. We built upon the theme from last year's forum series which was entitled "Expanding Our Understanding of God and Our Faith" with a kick-off with Steve Portalupi's excellent presentation on the Webb Telescope. As a contrast to last year's focus, our theme for the 2023-24 Red Door Series was entitled "Moving Inward to Discover and Deepen Our Personal Faith Journey". In this year's series, we wanted to hear from individuals within the congregation and beyond, sharing their stories of how their personal faith has been deepened and matured by events that happened and where God has led them.

A special thanks to the efforts of the Faith Formation Committee, consisting of members Patricia Gianotti, Ali Watt, Morgan McCay, Jen Murray, Kim Billings, John Hodson, John Woodard, Athens Pullias, and Kathryn Ringrose. This year, in addition to planning the speakers' line up for the year, the committee crafted a purpose statement as a means of growing and clarifying this ministry. The intention behind the purpose statement is to function as a guiding principle for all potential Adult Forum speakers as a way of grounding them in the committee's intention for the Sunday Forum Series. In this way we hope to offer a thread of continuity around the theme for this year's Red Door Series and years to follow.

The Purpose Statement is as follows:

"Community lies at the heart of our formation and worship together, which we build by offering a variety of groups and activities. Through these activities, we seek to grow our faith, supported by one another, creating a sanctuary space between and amongst us, so that we can carry the light of Christ and our faith into the world."

There have been a total of seven Adult Forum Presentations as of the date of this Annual Report.

- This year's Forum Series began on September $17^{\rm th}$ with our kick-off speaker, Stephen Gianotti, who presented his TedX Talk delivered live on The Music Hall Stage on May $11^{\rm th}$, entitled, "What we can learn from the African Elephant".
- This was followed by Suzanne Jalbert Jones and Lexie Munier who spoke on September 24th about the mission and outreach of one of our most successful ministries The Pine Street Players.
- On October 15th Robin Sirois was our guest speaker where she shared her work as part of a surgical team, through Resurge International, where she helps to bring life-changing results to patients in need in Vietnam, Bolivia, and Nepal.
- Molly Zirillo, Executive Director of St. Vincent de Paul, a non-profit organization dedicated to helping to distribute food, clothing, and medicine to those in need in our community, gave a talk to participants of the forum on October 22nd.
- On November 5th Jean-Bosco Rutagengwa spoke on the topic of his book Love Prevails: Faith and Survival in the Rwandan Genocide.
- Advent brought to us two panel discussions, the first on December $3^{\rm rd}$ entitled *Alienation from the church and reconnection* with speakers Linda Woodard, Kim Billings, John Hodsdon.
- On December 10th, the panel discussion focused on *Unexpected places where* we discover God in our midst with speakers Jen Murray, Athens Pullias, and Jeff Neil.
- The Healing Team spoke at our January 21st Forum. Speakers included Judy Blaisdell, Robin Sirois, Patti Buck and Wendy MacArthur Keith sharing the blessings of their ministry of healing prayer by laying on of hands that they offer during our Sunday liturgy.

In addition to the Adult Forum Series, our community connection was evident through small group gatherings including Oasis Sisters, a women's group studying scripture and spiritually based books for the purpose of growing in faith and in their lives as followers of Christ. As a lay-led group, they meet together weekly on zoom in order to include some who can't join in person. Once a month they meet in person to socialize and support each other as they share personal stories. Lifting each other's prayer needs is a vital part of this community. Oasis is open to new members at any time.

The clergy-led Bible study meets Tuesday mornings and has been growing in attendance since returning to in person gathering last year. With a focus on one of the lectionary passages for the following Sunday, this group has the privilege of possibly influencing the upcoming sermon while wrestling with how the passage speaks to our lives in Christ. No preparation is required, just come and ponder. Drop-ins and all are welcome to join in this community building enterprise!

Throughout this year, based on the recommendations from the RenewalWorks efforts pre-Covid, the Vestry has continued to open our meetings with a scriptural passage followed by group discussion. This mandate of embedding ourselves in the Bible continues to enrich us as it provides a meaningful spiritual grounding and a way of deepening our connection with each other in alignment with discerning God's purpose.

Major tasks and goals that the Vestry accomplished during this past year include:

- · Completion of final revision of the Christ Church Employee Handbook, with the help of John Cofer, based on employee feedback to our initial draft.
- The creation of a new working agreement between Pine Street Players and Christ Church which more clearly outlines the guidelines for successful collaboration, including financial expenditures and shared responsibilities and expectations in terms of staffing and productions.
- · Continued update and streamlining of Quick Books and financials, thanks to our Treasurer, Dick Ingram, who has also agreed to fill in as Interim Bookkeeper.
- The hiring of our new staff member, Nicole Benevenia, Candidate for Holy Orders of the Diocese of New Hampshire, who officially began her contract as of January 2, 2024.

Music and Liturgy

Suzanne Jones

2023 offered robust programming. At the top of the year, Suzanne Jalbert Jones, who had been on music staff from 2013-2018, returned as Director of Music. As a hark back to prior years, the Good Friday Service featured *Fauré Requiem*. Included in this service was a chamber orchestra, consisting of 9 professional musicians from New Hampshire and the greater Boston area, a 53-person choir and 2 vocal soloists. We invited singers from Pine Street Players, musical colleagues from other choirs, and friends and family; we were overwhelmed with the turn out. Marc Fournier provided an illustration of Christ Church's own organ for the bulletin cover.

Because of the success of the requiem choir, we extended the same invitation for singers to join in our Christmas Eve Service. The Christmas Eve prelude included a choir of 30 singers, a flute trio, vocal solos and organ solos.

In terms of general programming, an infusion of gospel and contemporary music has brought great joy to the choir and parish. Over a dozen new pieces of music have been purchased for the choir library and the choir is becoming much more diverse in their repertoire of anthems.

narcissistic lawyer Billy Flynn, who encourages them to razzle-dazzle their way to the American Dream: fame, fortune, and acquittal."

Meanwhile, Beatrice's cousin and best friend Hero is set to marry Claudio. When the wedding is called off due to nasty gossip, Benedick swoops in to defend Hero's honor, ultimately endearing himself to Beatrice – in spite of themselves."

Much Ado About Nothing gave three performances – July 14, 15 & 16, 2023 – at Christ Church.

Summer Session, 2023

Our summer theatre workshops are crafted for young performers interested in a fast-paced, supportive, and creative environment led by experienced theatre professionals and educators. Providing an opportunity to build upon the skills and confidence necessary for success in mainstage productions, our leveled curriculum offers performers training appropriate to their age and ability. In addition to rehearsing a musical to be presented at the culmination of their session, performers take classes intended to expand their skills. Participants leave Summer Session with improved skills in acting, singing, and dancing, a better understanding of the audition and rehearsal process, and the kind of confidence that comes from socializing with like-minded friends while working together to create something to be proud of.

Workshops are held for two-week sessions: Monday through Friday, 9:00 AM – 3:00 PM. Performances take place at 3:00 PM on the final Friday of each session.

Fall Musical, 2023:

The Drowsy Chaperone, Jr. (Grades 1-6) and The Drowsy Chaperone (Grades 7-12)

With the houselights down, a theatre fan known only as The Man in the Chair appears on stage and puts on his favorite record, a cast recording of a fictitious 1928 musical *The Drowsy Chaperone*. The recording comes to life in the Man's apartment, as he comments on (and occasionally defends) the frivolously inconsequential plot and its seemingly two-dimensional characters: a show-business Bride and Groom on the eve of their wedding, a bumbling Best Man, a desperate theatre producer and his ensemble-bound girlfriend, a forgetful hostess, two gangsters posing as pastry chefs, a misguided casanova, and an irresponsible chaperone. Hailed by *The New York Times* as "a perfect Broadway musical," *The Drowsy Champerone* is a masterful meta-musical, poking fun at all the tropes that characterize the musical theatre genre - and asking the very important question of whether or not some storylines are best left in the past.

The Drowsy Chaperone, Jr. was performed by **57** performers in Grades 1-6. They gave three performances – November 10, 11 & 12, 2023 – at Christ Church.

Report of The Endowment Board 2023 and the Anchor Legacy Society

The Minister of the Congregation is directed to instruct the people, from time to time, about the duty of Christian parents to make prudent provision for the well-being of their families, and of all persons to make wills, while they are in health, arranging for the disposal of their temporal goods, not neglecting, if they are able, to leave bequests for religious and charitable uses. (Page 445 in the Book of Common Prayer)

In December 2014, the Vestry of Christ Church created a new Endowment Fund and set proper gift acceptance and spending policies. In 2015, we received a generous \$100,000 from a faithful member that seeded this new fund. The income from this new Endowment Fund is limited to capital improvements, developing new ministries, outreach ministries and special projects.

As of December 2023, the balance of the Fund was \$218,122.

Laura Tetrault, a member of Christ Church and our Endowment Board, is also a member of the Trusts, Estates & Guardianships practice group at Shaheen & Gordon. She concentrates her practice in estate planning as well as trust and estate administration.

On All Saints' Day each year, we recognize those who joined the Anchor Legacy Society by remembering Christ Church in their wills or making provision for the church through other planned gifts. In 2023 we recognized the **Rev. David Holroyd** as a new member. We also remember those who died in the previous year.

If you are making a Will or updating financial or estate plans and you would like to support God's work in Exeter and the wider church and community, please reach out to us for more information so that we can answer any inquiries you may have. In addition, we take this opportunity to remind parishioners that the Endowment Fund welcomes gifts for any occasion; it is not exclusively for bequests. Gifts in memory of a family member or friend are very appropriate; likewise, gifts in honor or in celebration of a person or event are equally desired. There are any number of occasions when a gift can be made, (birthdays, baptisms, graduations, anniversaries, good fortune, and others) recognizing the moment and helping to grow the Fund.

Report of Higgins Fund 2023

The Higgins Fund was established by Christ Church members John F. Higgins and Jeanne G. Higgins in 1978 to minister to the spiritual, mental, and physical needs of the elderly and infirm; to supply clergy, aides, teachers, social workers, or others to assist in their wellbeing; and to aid the indigent who may need monetary assistance at home or in health care institutions on the Seacoast.

As currently directed by the Trustees of the Fund, an individual may receive no more than \$1000 during one calendar year from the Fund.

During 2023 \$2429.78 \$2829.99 was distributed to eligible applicants.

As of December 31, 2023, \$2035 was held in cash reserves. \$24,757 remains invested with the Diocese.

Our Companion Parish Relationship with San Francisco de Asís in Cardenas, Cuba

Traveling to Cuba is always an uplifting and a heart-rending experience. The flight from Miami is barely thirty minutes in the air. As a traveler clears customs and exits the airport, it is as if one is transported decades back in time: horse-drawn carriages are a main means of transportation, not a tourist prop, and the few cars on the road are large American models from the 1950's and Russian Lada's being held together by the mastery of Cuban mechanics and spare parts from around the world.

The Cuban people, after Pandemic isolation and prolonged hardship, six decades of oneparty rule and neglect, trade, and travel embargos from the United States, and increasing migration hollowing out the country, are tired and almost without hope for a better future.

On March 13, four members of Christ Church with Mark visited our companion parish in Cardenas, Cuba for one week. Christ Church has sent seven delegations to Cuba in nine years, with their largest group in 2019 joined by Bishop Rob. On this trip, we carried down needed medicines and spare parts and filters for various water systems throughout the diocese. In January, the Sustainable Development Goals (SDG) sub-committee of the Diocese made a grant of \$5000 to Christ Church to be used to transport and install a U.V. water filtration system for the Church of the Annunciation, in the town of Florida, Camaguey Province.

The Cuba of today suffers through rolling blackouts, food shortages, lack of basic medical care and medicines, widespread dengue fever, and simmering civil unrest. Many young people and professionals are fleeing the island for the U.S., causing a familiar "brain drain" of skills and leaving many children to be raised by grandparents as they await family reunification.

The Cuban Episcopal Church remains a source of inspiration and welcome in an otherwise bleak landscape. Reunited with the Episcopal Church in 2018, the Diocese of Cuba is a witness to the power of Christ to be present in times of struggle and exile.

In April, 2024 Christ Church will return to Cardenas to reconnect and to continue to support this mission venture.

Treasurer's Report

I offer this report in three parts:

- The first evaluates our financial position on December 31, 2023. This is a review of our assets and liabilities on the balance sheet of the parish.
- The second looks at how we got to where our finances stood at year end.
- The final step is to look ahead at 2024 and the budget for the next year.

How did we stand at year end?

As we start 2024, we are in a position that many other churches and organizations like Christ Church would envy.

Our cash balances are strong, totaling nearly \$300,000. The balance of the checking account we use to record deposits and pay our bills was nearly \$97,000. This is higher than you might expect in part because the company that replaced the skylight in the church had not yet cashed the check for the \$36,000 final payment. Still, this is a strong operating cash position. I will describe the balance in our Edward Jones account more fully below. Pine Street Players (PSP) had roughly \$41,000 at its disposal at year end. This is comprised of funds in their operating checking account, the balance available in their debit card account, and some \$11,000 set aside as a reserve. It is worth noting that during 2023 PSP generated adequate funds to return the monies the parish had advanced several years ago to establish their debit card account.

We also maintain a reserve account that has nearly \$105,000 set aside for a variety of purposes. One is a Building Improvement Reserve that we are accumulating to have funds on hand for future building needs. We were able to add to that this year. A significant component of our financial position are the various endowment accounts managed through the diocese. The values shown in the balance sheet are as of September 30, 2023, since we have not yet received the year end numbers. I would expect them to be a bit higher, continuing the improvement over last year. While several of these accounts reinvest any earnings, most distribute currently at a rate established by the diocese.

Our liabilities are minimal. We owe just a bit more than \$60,000 on the loan from the diocese that we acquired to pay for the skylight replacement. We also had several parishioners who had prepaid their 2024 pledges prior to year-end. The proper accounting for this is to record the prepayment as a liability that we will "earn" during 2024. These prepayments, along with several others that were paid in early January have been deposited in our Edward Jones account. Once the total prepayments have been received (now nearly \$70,000) we will draw down the balance at Edward Jones in equal monthly installments and reduce the liability accordingly. This is a prudent way to manage our cash during the year.

We do not record any accounts payable since we pay all our bills within 30 days of receipt.

How did we get there?

The results for 2023 show a small deficit from operating revenue and expenses and a net surplus after adding in non-operating revenue and expenses.

I would note that in addition to the operating revenue and expense shown in the P&L, we made contributions to our reserves of \$10,000 for the building improvement reserve and \$2,000 for the clergy sabbatical reserve. These were shown as expenses in the original budget. However, our accounting software could not show them as expenses, so they are shown here "below the line" as balance sheet transfers, since the money does not leave the parish as with other operating expenses.

The most significant negative surprise was a dramatic reduction in the income we receive from the Leacock Trust. Christ Church and the Diocese are co-beneficiaries of this trust. It was established back in the early 1950's with the directive to distribute income to Christ Church and the Diocese to help pay for our curate and assisting priests elsewhere in the diocese. In recent years both the Diocese and Christ Church had been receiving some \$5,000 each month. In May this was reduced to \$2,400 without advanced notice or adequate explanation as to why. Had historic distributions continued we would have ended the year with an operating surplus. I have had discussions with the Diocesan CFO, and we will be working together to pursue our concerns about this situation with the probate court and the Trustee, BNY Mellon.

Our pledge and plate income for 2023 on a combined basis came in slightly above budget. 2023 pledges were on budget and a significant overbudget collection of unpledged donations offset a shortfall in what we expected for catching up on unpaid 2022 pledges.

We managed expenses in a manner that largely offset the shortfall in Leacock Fund revenue, leaving us with a small operating deficit.

Non-operating income was strong, led by another good year financially for Pine Street Players (PSP). As I noted above, as they continue to mature as a program, we are working closely together to maintain good financial practices.

We also received two bequests that totaled \$15,000. These were transmitted to the diocese and added to the Christ Church Endowment balance.

Overall, a good year for Christ Church.

What's Next?

The promising financials from 2023 lead us to our budget for 2024. This was approved by the vestry at its January 9^{th} meeting.

As I write this, pledges continue to come in. We are grateful to all who pledge and encourage those who have not yet pledged to do so. It's never too late! We also are grateful for the number of parishioners who give as they are able during the year. We know circumstances change and can often be challenging. We continue to be surprised and blessed by your generosity, both pledged and unpledged.

The budget for 2024 shows an operating deficit, as we did last year. This is not a cause for concern. I note above that pledges continued to come in and we can very reasonably expect to exceed our budgeted pledge income. The diocese indicated that our endowment distributions will increase by nearly 5% and as noted above we will be pursuing remedies regarding the Leacock Fund.

Our 2024 expenses are essentially in line with last year. One significant change is that we have returned to more "normal" clerical staffing with Nicole Benevenia joining us. We are already reaping the benefits of her presence. As you are aware, her husband is the rector in Durham and Christ Church is sharing the cost of the family medical insurance required by the diocese. This is an arrangement that benefits Christ Church, St. George's, and the diocese as we support young clergy in their ministry.

We continue to set aside funds for future building needs and clergy sabbatical coverage. You will also note that for the first time we have provided for a sharing of net revenues between PDSP and the parish. A tribute to the maturing of that program, dedication of their leadership and the important role they play sharing Christ Church with the community.

I look forward to your questions at the Annual Meeting and at any time during the year. It is my privilege to serve the parish.
