2024 Rector's Report

2024 was an extremely full and fruitful year for our mission and ministry here at Christ Church. Our worship attendance is returning close to pre-pandemic numbers, and there are many new faces in our pews.

"Together in Joy" was our stewardship formation theme this past year. We benefited from a focused and hard-working sub-committee of the Vestry that published weekly reflections beginning over the summer months. I thank all those who stood up in church and shared their spiritual journey and how it connected their desire to be generous in their financial support of the work we do.

On November 10 Cary Einhaus spoke at the 8:00 a.m. service. He said this near the end of his bold and heart-felt sharing:

"I appreciate that we are a community here that seeks to come together in worship; to grow in our faith and knowledge of God, however imperfect; to strive to live our Sermon on the Mount values to create a world of world of kindness and compassion and joy as we follow the way of Jesus. And the only way that we can reach out to those spiritual seekers who are marginalized, to those who feel unwelcomed by many who call themselves Christians, is by lifting high the Gospel message that God's mercy and love, like the communion bread we share around this altar, is exclusive to no one."

There is a lot said these days about how divided and polarized we are as a nation. The topic resurfaces in many a sermon and is spoken of often by many of our members. And a church should be a place centered on the unity of God's message for the world. On our better days, I have seen us work towards God's dream for us as being truly One in Christ.

There was joy in the calling of Nicole Benevenia to join our staff in January, working half-time as she prepared to be ordained a deacon in June. Nicole made an immediate impact with her insightful preaching, warm presence and her organizational skills to assess and build up our formation program for children and young people. When baby Jeremiah was born in April, and after a few months of parental leave, by the early summer the now Rev. Nicole was back with us working ¾ time. Perhaps I do not mention enough that her work with us is somewhere between full and half-time, and that can be hard to navigate for any profession: Nicole is doing so with grace and dedication. I promised her that Christ Church would be a wonderful learning environment for a newly ordained priest. For me personally, Nicole's joining our staff has given me the most assisting clergy help hours-perweek that I have had since the fall of 2013. Suffice to say: I'm thrilled and thankful!

2024 saw the continued collaboration and support with our Pine Street Players youth theatre program and ministry. This program continues to impact hundreds of children and teens in our local and extended community, offering a space to learn and grow. On many afternoons and evenings during the week we can all be proud that our space is being used for art, dance and theatre.

My role in facilitating the monthly Men's Group continues to be extremely satisfying as we routinely gather from ten to fifteen men for sharing, fellowship, and learning.

I mention each year in this report my work at the Stafford County jail in Dover, serving on their Spiritual Life Committee and visiting ICE detainees, many of whom speak Spanish, who are awaiting asylum hearings and deportation. I do so because the good people of Christ Church have allowed me to extend my ministry to this population as a critical time in our nation's debate and challenge around immigration.

At the risk of failing to mention some folks, I do wish to recognize the following persons:

- ❖ Outgoing Members of the Vestry: Jen Murray, Morgan McCay, and John Hodsdon rotate off vestry at this Annual Meeting. Thank you for your dedication and faithfulness. Jen worked with our Faith Formation Committee and helped reboot and strengthen our hospitality ministry. Morgan worked this past year on our stewardship education and also contributed to the Red Door Forum series. John offered us his keen insight during many meetings, also supports the forums, and shared his global travels with us. What a contribution they have all made.
- ❖ **Richard Ingram** served as both Treasurer and Bookkeeper throughout 2024, helping streamline our financial record keeping. He also continued to be an invaluable liaison and supporter of our Pine Street Players.
- ❖ **Susan Dixon** spent many hours over the summer organizing our parish records and piles of vestry files in the Archive Room off the Community Room. It was and continues to be a labor of love and much needed for the preservation of our history. Assisted by **Dale Cavanaugh**, we hope to open the room soon for exhibits and displays.
- ❖ Our Streaming Tech volunteers: We could not offer this ministry without the dedication of Joe DiPalermo, Leslie Pendleton, and Will Sera. And yes, we are always looking for new folks who would like to train and rotate in a few Sundays a month.
- Members of the Altar Guild are the hardest working folks one never sees do their work! Thank you, Sue Ingram, for your shepherding of this group.
- ❖ **Joe DiPalermo**. What can I say? He is the indispensable non-staff person who helps us offer what we do, especially to the many outside groups that use our space.
- ❖ At the close of 2024: Members of the core church staff: Nicole Benevenia, Darla Watt, Bruce Adami, Suzanne Jones, George Malgeri, Richard Ingram and Lexi Meunier. The staff of any church is fundamental in carrying out the work we have been given by the elected leadership. We have been fortunate to have the people we have making so much of what we do possible.

Curate's Report

Rev. Nicole Benevenia

I started as the Curate at Christ Church in January 2024. This calendar year was one of tremendous transition in my life. In April, my second child was born; in June, I was ordained a transitional deacon; and in December, I was ordained a priest. I took a much-needed parental leave in the spring and returned in the summer to begin planning for my first full program year here in Exeter.

In any new ministry role, the first few months to year are focused on learning the rhythms, dynamics, and traditions in the community. In 2024, I had two areas of focus: first, our children's and youth ministries, which I address in a separate report. Second, I learned the role of deacon in our liturgy and have just started learning how to be a priest: including participating in my first Holy Week, first funerals, and first Christmas season at Christ Church. As I get more experience in these areas and they start to settle into more known patterns, I'll gradually be able to shift my attention to more areas of our communal life.

This past year has also been about building relationships: getting to know people and becoming known. I've been honored by this community's reception of my preaching - and as we grow together, I hope I will continue to hear what the Spirit is saying to God's people here in our corner of the church. I've been tremendously honored by those of you who have begun entrusting me with your questions, struggles, losses, griefs, and joys. These are the vulnerable corners of our work together, but no real growth can happen without vulnerability or risk.

As we move into a new year, I want to thank my colleagues and all of the lay leaders (of which there are many!) for teaching, welcoming, and mentoring me in this new role. I'm looking forward to what we will do next together.

Children's and Youth Formation

Rev. Nicole Benevenia

We continued to offer two Sunday school classrooms for ages 5-12 in 2024, using the Feasting on the Word curriculum. From January 2024-May 2024, we offered Sunday School for all ages during the 10 a.m. service. When the new program year began in September, we decided to shift. We continued to hold Sunday School for ages 5-8 at 9:45 a.m., with children returning to the later service at the time of the peace. We moved the older classroom (ages 9-12) to between the services, starting at 9 a.m. This decision was made primarily because we have a limited number of Sunday School teachers and having one class meet in between the services means that Mark is available to act as the lead teacher. This also has the added benefit of older children being able to attend either full service with the rest of the congregation if they choose. Our younger classroom saw anywhere from 1-6 children each week, and the older classroom, 1-4 children. We know that arriving at 9 a.m. can be a challenge for some families (and we recognize that we might have lost some

participation as a result). We are continuing to welcome new Sunday School teachers for those who are interested.

In September, we revived the Children's Chapel program at Christ Church! Held in the side chapel once per month, this is a brief worship service centering on children's participation and experience, including readings, a kids' sermon, prayers, and songs. Parents and caregivers are welcome to attend with children ages 5-12 but are not required to attend. Children under the age of 5 are also welcome in chapel, but we ask that caregivers attend with them. We return to the sanctuary for the sign of peace to join the rest of the congregation for communion. Whereas our Sunday School program emphasizes learning the stories of our faith held in scripture, in Chapel, we practice the rhythms, patterns, and actions of liturgy, and our traditions in worship together. Chapel services have seen anywhere from 6-10 participating children, with a number of adult caregivers joining us each week. Chapel has been a bright light and a real place of joy for me in this first year at Christ Church.

Our Youth Confirmation and Inquirers' class began in November (with the Bishop's visit planned for May 2025). A group of 3-4 youth are exploring the foundations of our Episcopal, Christian tradition as they discern whether the sacrament of Confirmation is the right next step.

We continue to have Philips Exeter Academy students join us for worship on Sundays, which certainly adds to our community, as they no longer have access to Protestant services held on campus. As I round the corner of my first year at Christ Church, I'm asking how we might engage these youth more.

Finally, the year ended with our traditional Christmas Pageant at the 4 p.m. Christmas Eve service. 17 children and youth and 3 grownups participated this year! We especially recognize the Steere and Gibson families for providing 25% of this year's cast, and Russell Weatherspoon, who graced us with one final performance as one of the three kings.

As I review our ministries and formation this past year, there are many people for me to recognize:

- Lexi Munier, for rehearsing our pageant cast through three rehearsals, as well as the parents and grandparents who made the pageant a success, especially Danielle Larson Clark, this year's costume coordinator.

Reflections on the Year:

2024 was a very full year at Christ Church. We have been blessed as we continue to rebound as a parish in the aftermath of Covid. The Vestry's priority has continued to focus on strengthening our community as we regather, reconnect, and affirm our connection with one another. This year we have expanded our efforts to stabilize and grow through continued outreach, with a specific focus on the reformation of our Stewardship Team. There were many events to celebrate this year. Among them was the Christ Church trip to Cuba in April with Mark Pendleton, Leslie Pendleton, and Dale Cavanaugh who brought supplies to our sister Church in Cardenas, Cuba. Christ Church was also proud to host the Diocesan Convention on October 26th. Thanks to the help of numerous volunteers from our parish, the event went off smoothly and seamlessly. In addition, we joyously celebrated the ordination of our Curate, Nicole Benevenia, as Deacon on June 8th at St. Paul's Church, and we celebrated her ordination into the priesthood at Christ Church on December 7th. To our knowledge this was the first ordination in combination with the baptism of Jeremiah Bourne at the same service celebration. Finally, our year was brought to a joyful conclusion during our Advent and Christmas season with wonderful music at the 8:00 service and stellar performances at the 4:00 service, with a special guest appearance by Russell Weatherspoon as one of the Magi. It was truly "The Best Pageant Ever". A very special thanks to Suzanne Jones, Bruce Adami, and the Christmas Choir who made the Christmas Eve and Christmas services absolutely magical.

A special thanks also goes out to our Hospitality Team whose dedication and culinary talents have made every celebration, every holiday gathering, every Red Door Forum event, and every Sunday Coffee Hour so welcoming. Thank you to committee members, Jen Murray and Kim Billings, co-chairs, Adrienne Spear, Linzee Coleman-Bagge, Cynnie Irwin, Ann Junkins, Ann Malconian, and Mary Webber.

In this year's Senior and Junior Warden combined Annual Report, we have focused in more detail on two Vestry and Committee initiatives that took place this year – our Adult Formation Series and our Stewardship Initiatives. The content of other ministry/committee reports will be covered in separate documents.

Adult Formation:

The Red Door Series continued to grow and thrive during this past year as we consistently gained new attendees. During this year's "Red Door Series", the attendance at each forum has averaged between 35-58 people. This represents approximately a 20% increase each year in the past three years. Just as we had done in previous years, the committee chose a theme for this year's forum focus, which was entitled "Let Your Light Shine". Building upon

our focus from the past two years, where the 2021-2022 forum focus invited us to "Expand Our Understanding of God and Our Faith" with a kick-off with Steve Portalupi's excellent presentation on the Webb Telescope, followed by the theme for the 2023-24 Red Door Series, entitled "Moving Inward to Discover and Deepen Our Personal Faith Journey", with our wonderful kick-off presentation by Stephen Gianotti speaking on What the African Elephants Can Teach Us About Community. In this year's series, we took a slightly different slant, and we invited people to think about how God's light shines within each of us as well as how we can spread that light into the world.

A special thanks goes to the efforts of this year's Faith Formation Committee, consisting of members, Patricia Gianotti, Ali Watt, Blake Carrico, Jen Murray, Kim Billings, John Hodson, John Woodard, Elaine Portalupi, Athens Pullias, and Kathryn Ringrose. As we prepared for this year's presentations, we began by reviewing our purpose statement with the intention of using this as a guiding principle for all potential Adult Forum speakers, in order to ground them in the committee's intention for the Sunday Forum Series. In this way we hope to offer a thread of continuity around the theme for this year's Red Door Series and years to follow.

The Purpose Statement is as follows: "Community lies at the heart of our formation and worship together, which we build by offering a variety of groups and activities. Through these activities, we seek to grow our faith, supported by one another, creating a sanctuary space between and amongst us, so that we can carry the light of Christ and our faith into the world."

There will be an additional seven forum presentations scheduled for the remainder of the 2024-2025 season. The committee is grateful for the interest and participation in this year's Red Door Forum series.

Stewardship:

During the March Vestry planning day, several of us volunteered for the adventure of forming the first Stewardship Team since well before the pandemic lockdown. Susan Dixon, Morgan McCay and Judy Blaisdell launched the effort by first consulting the expertise of Leslie Pendleton, then exploring the writings of Henri Nouwen, specifically "The Spirituality of Fundraising." This led us to create a presentation on Joy and Generosity as the final Red Door topic of the 2023-2024 season. We opened that topic with a brief video from the Bible Project, entitled "This Lie can Keep you from Living Generously."

Our purpose was to initiate a new approach to growing our understanding of how we are called to be good stewards of all the gifts our gracious God has bestowed upon us. The hope was to engage in exploring, over several months, where there is room for us to grow our giving hearts; how best we can do that; and what inspires us, sets us free to give of ourselves and our resources. Our question: how do Joy and Generosity relate to each other as we strive to be God's stewards?

Over the summer months, the team invited parish members to prayerful introspection through weekly messages that we wrote for the E-news and Sunday bulletins. We hope you have found these meaningful for personal reflection and growth. Our efforts culminated in the Fall Campaign of several parishioners speaking during Sunday worship of their personal commitment to pledging and, of course, the parish letters inviting your pledges for 2025.

We offer our gratitude to all of you who contribute in so many ways to helping our community thrive!

Music and Liturgy

2024 marked a great musical year for Christ Church. In March, Christ Church parish choir joined forces with local professional and recreational singers and instrumentalists in the area to perform Gounod's *Requiem* during our Good Friday service. Four professional vocalists sang the very difficult, yet beautiful, solo sections of this piece. Our very own, Christina DeMaio and Cathy Hammon were soprano and mezzo soloists, respectively. Boston singer, Mark Sciapucci sang the tenor solos and Richard Benefield sang the baritone solos. We were particularly excited to have Richard on the project, as the title of his dissertation for his doctorate of music was "The Organ-Accompanied Solo Motets of Franck, **Gounod**, and Saint-Saëns." The choir boasted nearly fifty singers, represented by our Parish choir, students from PSP and local singers. The small chamber ensemble of six included two violinists, a violist, a cellist, a bassist and a harpist.

Throughout the year, many new anthems were added to our collection. Specifically, the parish choir sang many anthems from the gospel tradition, which were very well received by the congregation. Laura Wyskiel, a parishioner, was a featured flute soloist on several

anthems. Many choristers performed solos during the summer Sundays, as did other instrumentalists from the parish.

Informally dubbed, the "Christmas Choir", the 8pm prelude and service on Christmas Eve featured a choir of nearly 40 singers, performing carols and anthems from the classical, gospel and modern musical genres. Similarly to the choir for Good Friday, this choir was composed of regular choristers, singers from the parish, the Exeter community, PSP population and friends of friends! The gospel number, "How Great Our Joy!" featured Christina DeMaio as a vocal soloist and Andrew Strout, a local jazz pianist, on piano. Both the participants and those in the pews were blessed by this musical offering.

The musical programming has continued to be richly spirited. We are proud of the dedication of our parish choir and their contributions to all musical offerings at Christ Church. We are also excited to see how our group of auxiliary singers has taken form. There is a group of over 50 singers who choose at least one of our "extra" services (Good Friday or Christmas Eve) to participate in. Many have formed family traditions around singing with us on Christmas Eve. In this way, our choir is blessing the greater Exeter and Seacoast communities.

strangest, surrealist ways. Hearts are broken and healed, relationships are lost, found, and confounded, and the people of Almost, Maine will never be the same. It's almost love - but not quite.

Our summer theatre workshops are crafted for young performers interested in a fastpaced, supportive, and creative environment led by experienced theatre professionals and educators. In addition to rehearsing a musical to be presented at the culmination of their session, performers take classes intended to expand their skills. Participants leave Summer Session with improved skills in acting, singing, and dancing, a better understanding of the audition and rehearsal process, and the kind of confidence that comes from socializing with like-minded friends while working together to create something to be proud of.

Building & Grounds Committee (B & G)

Introduction and Overview:

Each year the Building & Grounds Committee focuses on annual maintenance activities, building upgrades, future project planning, and long-term building maintenance planning working with the Senior Sexton and reporting to the Vestry. In 2024 the Building & Grounds Committee held three (3) meetings.

The Skylight was completed in the Fall of 2024 and the B & G Committee finalized plans on the courtyard project, which includes new walkways and platforms in front of the three entrances (Narthex, Harris Hall, and Vestibule Entrances) with two automatic door openers for the Narthex and Vestibule door entrances making the Church and Harris Hall more accessible for ALL.

2024 -2025 Projects:

- M & M Skylight installed a new skylight in the Fall 2024. This includes all new flashing
 and structure as needed and new asphalt shingles and hips nearest to the skylight on
 four sides of the skylight.
- Courtyard Project Drawings were submitted to Vestry (with estimate by the General Contractor) and approved. This project is scheduled for construction and completion this Spring 2025.

Long term finance planning to replace MEP equipment and building maintenance projects continues by the Vestry for future and maintenance projects.

Report of The Endowment Board 2024 and the Anchor Legacy Society

The Minister of the Congregation is directed to instruct the people, from time to time, about the duty of Christian parents to make prudent provision for the well-being of their families, and of all persons to make wills, while they are in health, arranging for the disposal of their temporal goods, not neglecting, if they are able, to leave bequests for religious and charitable uses. (Page 445 in the Book of Common Prayer)

In December 2014, the Vestry of Christ Church created a new Endowment Fund and set proper gift acceptance and spending policies. In 2015, we received a generous \$100,000 from a faithful member that seeded this new fund. The income from this new Endowment Fund is limited to capital improvements, developing new ministries, outreach ministries and special projects.

As of December 2024, the balance of the fund was \$255,163.

Laura Tetrault, a member of Christ Church and our Endowment Board, is also a member of the Trusts, Estates & Guardianships practice group at Shaheen & Gordon. She concentrates her practice in estate planning as well as trust and estate administration.

On All Saints' Day each year, we recognize those who joined the Anchor Legacy Society by remembering Christ Church in their wills or making provision for the church through other planned gifts. In 2024 we recognized **Nancy Fleming**, and **Donna and Morgan McCay** as new members.

If you are making a will or updating financial or estate plans and you would like to support God's work in Exeter and the wider church and community, please reach out to us for more information so that we can answer any inquiries you may have. In addition, we take this opportunity to remind parishioners that the Endowment Fund welcomes gifts for any occasion; it is not exclusively for bequests. Gifts in memory of a family member or friend are very appropriate; likewise, gifts in honor or in celebration of a person or event are equally desired. There are any number of occasions when a gift can be made, (birthdays, baptisms, graduations, anniversaries, good fortune, and others) recognizing the moment and helping to grow the Fund.

Report of Higgins Fund 2024

The Higgins Fund was established by Christ Church members John F. Higgins and Jeanne G. Higgins in 1978 to minister to the spiritual, mental, and physical needs of the elderly and infirm; to supply clergy, aides, teachers, social workers, or others to assist in their wellbeing; and to aid the indigent who may need monetary assistance at home or in health care institutions on the Seacoast.

As currently directed by the Trustees of the Fund, an individual may receive no more than \$1000 during one calendar year from the Fund.

During 2024 \$1840 was distributed to eligible applicants.

As of December 31, 2024, \$863 was held in cash reserves. \$29,011 remains invested with the Diocese.

Our Companion Parish Relationship with San Francisco de Asís in Cardenas, Cuba

Due to the declining conditions on the ground in Cuba, we were only able to send a small delegation to Cuba in April, 2024. Leslie Pendleton and Dale Cavanaugh joined me for a visit to Cardenas. Christ Church has sent eight delegations to Cuba in ten years. On this trip, we carry down needed medicines and spare parts and filters for various water systems throughout the diocese.

Cuba continues to be a country near economic collapse. Rolling blackouts are now daily occurrences. The same conditions in past reports are growing worse each day: food shortages, lack of basic medical care and medicines, widespread dengue fever, and simmering civil unrest. Crime is also on the rise.

In March of 2025 the Cuban Episcopal Church will hold an election for their next bishop. The Rev. Aurelio de la Paz, rector in Cardenas, is a candidate.

God willing, I hope to lead a larger group to Cuba in March or April 2026.

Treasurer's Report Richard Ingram

It has been a privilege to serve as your treasurer for the last three years. I am uplifted every day by the faithful support that comes in many ways from all of you.

I begin this report with a note of thanks to Patti Andrews. Some of you may recall that at last years' annual meeting I was complaining about what a tortuous experience using QuickBooks to keep our financial records was. Soon after Patti suggested I look at a software platform called Aplos. Mirabile Dictu! (I still recall a bit of high school Latin).

Salvation from the choir! We switched to this software on July 1, and it has transformed the financial recordkeeping. This was a necessary step after we had lost two bookkeepers in a twelve-month span. My goal was to better prepare us for future changes in personnel and to make our records more efficient. Mission accomplished thanks to Patti's suggestion. I am currently working with Jason Mignone to transition the bookkeeper role to him. It is worth noting that while Aplos is a bit more expensive than other software it is more than paid for by savings in bookkeeping expense and offers enhanced features that we will be exploring in the future.

We end 2024 in a strong fiscal position. That is thanks to the extraordinary generosity of both new and longtime parishioners and the positive results in our endowment funds.

Some points of note would include:

- Our endowment balances rose to over \$3,000,000 as of September 30 and will be even higher once the December balances are available. Distributions from the endowment will increase by 3% in 2025.
- Working together with the Diocese we have made progress in getting more information from the manager of the Leacock Trust. We will meet with them again in March and anticipate the distributions from that fund will increase a bit as well in April or May.
- Pledges continued to come in after the 2024 budget was approved so that our pledge collections
 were well above the budgeted amount. Of note for the 2025 budget is a continued growth in our
 pledge income.
- Unpledged donations were once again very strong as we had several new members join during the year and begin to give generously. That included a special \$80,000 contribution that will pay for improvements to the sidewalks and doorways into the church and Harris House later this spring. Improved and easier access has been a need for some time and the hard work that Kevin Clark and the building committee have put in over several years will finally bear fruit.
- Several members prepay their annual pledge in advance. We improved the accounting for this in 2024. Rather than leave these monies in the operating checking account and lull us into a false sense of plenty early in the year, we deposited all prepaid funds into our brokerage account at Edward Jones. This allowed us to earn about \$2,000 of interest oncome. We then recognized the income monthly during the year and transferred the monies into our checking account ratably each month. We will do this once again in 2025.
- These positive events allowed us to make the budgeted deposits into our building improvement reserve and clergy sabbatical reserve. This had not happened in recent years.
- Christ Church contributes over \$80,000 to the Diocese as our Fair Share of support. That contribution is calculated as 15% of certain income the parish receives. We can expect that to go up in 2025 when it is reset in April. Fair Share contributions from parishes throughout New Hampshire support roughly two thirds of the Diocesan budget. In addition to staff costs for the bishop and staff, the Diocesan budget supports the national church with a similar fair share type contribution, grant programs for children and youth, clergy support and development, lay leadership development, grants and loans to congregations and miscellaneous other support.
- We have not made financial grants of outreach funds for many years and much of our outreach is performed in kind by the support we offer to the families at Seacoast Family Promise, the holiday food and gift giving, and the subsidized use of the building for a myriad of support groups and agencies. Much of our financial outreach comes through the Rectors discretionary fund and include gifts to:

- o Our companion parish in Cardenas Cuba
- St. Vincent DePaul Society
- o Episcopal Relief & Development
- o Ascentia
- Seacoast Family Promise
- o Waypoint
- o Individuals in need
- We had no surprises on the expense side of the ledger and tried to be good stewards of your pledge dollars.
- Pine Street Players ended the year with a deficit slightly over \$12,000. Despite this they end the year with some \$27,000 in cash at their disposal. Much of the deficit can be attributed to several things that will not recur. They purchased a sound board for \$3500 that will save significant rental costs in future shows and pay for itself in roughly 12-18 months. They also purchased clothing and other items for \$4500 that will be sold for fundraisers in 2025 and that will more than recoup their cost. A ten-year anniversary gala incurred a \$3500 cost that was a one-time event. Program revenues were strong, but the collapse of the adult advisory group hurt fundraising. Plans to recover from that are in process.

You have heard me say more than once that a church budget is an act of faith and that it will always work out in the end. The year 2024 is a prime example of that here at Christ Church. People want to be part of something good and successful. When they are they will support it. You all are part of something good at Christ Church and your support is both inspiring and humbling.

2025 Budget Comments

Following this narrative is the budget approved by the vestry earlier this month. So that you can easily compare the numbers, it includes columns for 2024 actual results, the 2024 budget, and the 2025 budget.

The 2025 budget projects a deficit of just under \$3,000. This is significantly lower than the deficit projected in the 2024 budget, which we successfully eliminated. The small budget deficit for 2025 should be easy to successfully manage because:

- We do expect a few additional pledges to continue to trickle in building on the strong response to our stewardship campaign.
- We have once again conservatively budgeted for unpledged donations and the weekly loose plate collections.
- We will once again carefully monitor expenses during the year. The only significant change in projected expenses year over year is to reflect the fact that we will have Nicole with us for a full year as ordained clergy.

A few other comments are in order:

- Payroll costs are our single biggest expense. We have included a 2.5% increase for staff wages.
- Our endowment income will increase slightly with quarterly distributions set to rise by 3%.
- We expect an increase in the monthly distributions from the Leacock Fund. Those
 will increase beginning in April or May. We are scheduled to meet with the fund
 manager in March to discuss just how they will be determined.
- The monthly Fair Share payments to the Diocese will likely rise in April. The budgeted amount is an estimate and likely is a bit high.
- Pine Street Players projects a small surplus. They continue to attract new youth into the program and have budgeted for that. Any actual surplus will be added to their reserve funds.

In sum, this budget reflects the strong and faithful support of the congregation for the many and varied ministries we provide. Thank you for that support and for making the responsibility the vestry has in managing the parish affairs a joyful one.
