

## 2025 Rector's Report

2025 was another full year of ministry here at Christ Church. There were many moments to celebrate. There were some retirements and leave-takings. And there were times when we gathered to mourn loved ones. Throughout, God was with us.

A phrase I heard used by a clergy colleague describing the challenges of doing and being the church in today's culture post-Pandemic – keeping a worshipping community healthy and moving forward – is: "Flat is the new up!" Meaning: just keeping our doors open, welcoming, praying, worshiping, and "holding our own" is something to note and give thanks. I could not agree more.

The movement of the Holy Spirit is not easy to measure in ways we can always see and count. We can not always see and know those who have been challenged, supported, inspired, healed and comforted by what we do here with God's help. What I say to newcomers looking at the Christ Church as a possible church home: it is the lay people who do the caring here. When and if people open themselves up to others, connections are made and people do genuinely care and show up for one another.

What we can measure is that our worship attendance is returning to pre-Pandemic numbers, and there are new faces in our pews. Our on-line YouTube worship service gathers people far and wide.

With music being so much a part of our worship, 2025 was a year of transition. Our own parishioner Richard Benefield held down the organ bench as we searched for Bruce Adami's successor. Suzanne Jalbert Jones concluded her return run as Director of Music and was admitted to Medical School. We as a community could not be more proud of her achievements and we get to have her still as part of our community as a singer and parishioner.

Adam Peithmann was interviewed and recruited to join our staff as our fulltime Director of Music and Organist in July. Already we are getting the sense of his organ playing skills, his playful spirit in his music, and his easy-going nature and rapport with the choir. Welcome Adam and his family to Christ Church.

The Rev. Nicole Benevenia completed her second year of ministry with us that culminated with her being named Associate Rector in January, 2026. As I wrote at the time of this change in title: Nicole is a gifted preacher, an attentive listener, an able administrator and, for me, a trusted colleague. Christ Church is enriched by her ministry among us. She continues to work  $\frac{3}{4}$  time.

My role in gathering the monthly Men's Group continues to be extremely rewarding as we routinely gather from fifteen to twenty men for sharing, fellowship, and learning.

My work at the Stafford County jail in Dover continues. I began nine years ago. I serve on their Spiritual Life Board and visit a growing number of ICE detainees. I do not take for granted that Christ Church has allowed me to extend my ministry to this population at a critical time in our nation's debate and challenge around immigration.

At the risk of failing to mention some folks, I do wish to recognize the following persons:

- ❖ **Outgoing Members of the Vestry:** Alice Bentley, Susan Dixon and John Woodward rotate off vestry at this Annual Meeting. Thank you for all that you brought to our meetings.
- ❖ (Taken from my report last year) **Joe DiPalermo.** "What can I say? He is the indispensable non-staff person who helps us offer what we do, especially to the many outside groups that use our space."
- ❖ To all who knew, respected, and loved Joe, his sudden death this past July impacted many of us. We still invoke his name when we say: "Joe used to do that" or ask: "What would Joe do?" He lived for this church and considered it his family. Rest in peace Joe+
- ❖ **Members of the Altar Guild** are the hardest working folks one never sees. Thank you Diane DiPalermo and Patti Buck for your shepherding of this group.
- ❖ **At the close of 2025: Members of the church staff: Nicole Benevenia, Darla Watt, Adam Peithmann, Jason Mignone, Lexi Meunier and Nick Castillo.** The staff of any church is fundamental in carrying out the work we have been given by the elected leadership. ## **Children, Families, and Youth Formation**

The Rev. Nicole Benevenia

Christ Church continued to offer weekly Sunday School, monthly Children's Chapel services, and weekly childcare during the program year. Beginning in September 2025, we made some changes to Sunday School classes. First, we hired Katie Mize as Christian Formation and Children's Liturgy Support. This enabled us to return to our former schedule of both Sunday school classes being offered at the same time, and during the 10 a.m. service. Katie is the lead teacher for the ages 9-12 Sunday School classroom, and I believe having a dedicated and consistent teacher there has contributed to more consistent attendance for that age group. Our ages 5-8 classroom gained a new regular teacher, which brings the total to three teachers for the younger class.

We also continued to offer Children's Chapel monthly during the program year. This is a worship service centering children's participation and experience, including readings, a kids' sermon, prayers, and songs. Whereas Sunday School emphasizes learning the stories of our faith in scripture, in Chapel, we practice the rhythms, patterns, and actions of liturgy, and our traditions in worship. Chapel services have had steady attendance with most months having 6-10 participating children, along with some adult caregivers. We've also added a few more adult volunteers, in addition to Katie's leadership with music. Most importantly, I've received feedback from several parents about how their children really enjoy chapel, look forward to it, and are taking elements of what we talk about there home with them. It's a joyful and vibrant space!

Our Youth Confirmation and Inquirers' class concluded with Bishop Rob's visit in May 2025. Three teenagers were confirmed that day - my first ever Confirmation class! In 2024, we had a notable uptick of Phillips Exeter students joining us for regular worship, as Protestant worship services on their campus were discontinued. Happily, in 2025, several of these students have started lectoring at the 10 a.m. service. In addition, Fleur Phillips (one of those confirmed in May 2025) has taken on a significant parish history project reviewing the archives of Caroline Harris. We are excited that these connections between our parish and current PEA students are deepening.

As usual, we were glad to offer some annual events that extend a broader welcome to the community: the Easter Egg Hunt on Holy Saturday, and the traditional pageant on Christmas Eve. These events regularly include children from our regularly-attending parish families, Pine Street Players participants, and children who regularly travel over these holidays and have come to know Christ Church Exeter as a positive annual presence in their lives.

As I review our ministries and formation this past year, there are many people for me to recognize and thank:

- Katherine Steere Gibson, John Cofer, and Susan Dixon, teachers for the Ages 5-8 Sunday School classroom
- Katie Mize, teacher for the Ages 9-12 classroom and music lead for Children's Chapel
- Our lay adult volunteers (Dale Cavanaugh, Colleen Anders, and Krissy Green) for helping with Children's Chapel

- Lexi Munier, for rehearsing our pageant cast through three rehearsals, as well as the parents, grandparents, and church members, who made the pageant a success. I'd like to give a special shout-out to George Bagge, who did the last-minute painting and construction that gave us a complete manger scene in time.
- Chloe Davis and Quinn Fournier, our Sunday childcare coordinators.

### **Curate's Report**

In last year's report, I reflected on my first calendar year at Christ Church, as well as all the transitions and firsts it contained - my ordinations and the birth of my second child. This year, instead, the theme was the growth and deepening of existing ministries. A summary of our Children's, Families, and Youth formation programs can be found above. Outside of those, I'd like to highlight the Red Door Forum series and our growing Labyrinth Ministry.

Over the summer, the forum committee met to brainstorm new possibilities for the 2025-2026 forum lineup, and we were able to solidify most of the schedule for the program year early in the fall. Our first few forums have been well-received, with topics ranging from the role hymns play in our worship and spirituality; the state of immigration; human trafficking; and Celtic Spirituality. The committee brings a great deal of passion and is committed to community learning on a variety of different topics in faith and spirituality.

Back in the spring, parishioner Robin Yergeau approached me about the use of our outdoor labyrinth on the front lawn. In her previous parish, Robin completed a training as a labyrinth facilitator, and felt called to offer this as a regular spiritual practice for the people of Christ Church and the surrounding community. Robin offered monthly, guided labyrinth walks through the summer and early fall, as well as a morning workshop in October. We saw steady interest and participation, and are continuing to plan ways to develop this ministry in Exeter.

Finally, I'm grateful that in 2025, our vestry approved an extension of my work here along with a promotion to Associate Rector. Thank you for the trust you continue to give me as one of your clergy.

Thank you, Suzanne and Adam for working together to make our Advent and Christmas Eve services a glorious experience. You brought out the best in our parishioners who joined the choir to enhance our music and fill the sanctuary with a joyful noise. Thanks also to our Sunday Readers and Intercessors who bring scripture to life as a way of enhancing our worship experience.

A special thanks also goes out to our Hospitality Team whose dedication and culinary talents have made every celebration, every holiday gathering, every Red Door Forum event, and every Sunday Coffee Hour so welcoming. Thank you to committee members, Jen Murray and Kim Billings as co-chairs, as well as Adrienne Spear, Linzee Coleman-Bagge, Ann Junkin, Ann Malconian, Elizabeth Bauman, and Mary Webber.

In this year's Senior and Junior Warden combined Annual Report, we will summarize Vestry and Stewardship Initiatives as well as ministries that may not be represented in separate sections of this Annual Report. The content of other ministry/committee reports will be covered in separate documents.

### **Adult Formation:**

The Red Door Series continued to thrive during this past year. Nicole Benevenia took on the role of Chairperson of this committee in September of this year, launching a new season of the Red Door Series. Attendance at each forum continues to average between 35-58 people. A special thanks goes to the efforts of this year's Faith Formation Committee, consisting of members, Nicole Benevenia, Kim Billings, Jen Murray, John Woodard, Athens Pullias, John Hodsdon, Alison Watt, Elaine Portalupi, Blake Carrico, and Patricia Gianotti.

As a reminder, the grounding principles that the Forum Committee is based on is reflected in the Purpose Statement which is as follows: *"Community lies at the heart of our formation and worship together, which we build by offering a variety of groups and activities. Through these activities, we seek to grow our faith, supported by one another, creating a sanctuary space between and amongst us, so that we can carry the light of Christ and our faith into the world."*

### **Stewardship:**

The team of Morgan McCay, Susan Dixon, and Judy Blaisdell continued their work this year with a theme of "A Chorus of Generosity," the focus being on music as a metaphor for harmony and generosity. As a community that sings together throughout our worship, we serve and care for each other, our neighborhood and God's wider world in many ways. We may each sing the notes differently but together we create a beautiful harmony, purposeful in sharing God's love. We welcome all, work together as a community of love and make a joyful noise...a chorus of generosity!

During September, all were invited to “vote” for 3-5 of their favorite hymns. Once the results were tabulated, we had a singing forum in early October where the top faves were shared. No great surprise that “Amazing Grace” and “How Great Thou Art” and “Lift High the Cross” were among the very top of the list!

Accompanying that activity, several parishioners graciously shared reflection pieces through the weekly eNews on how they have experienced generosity in their lives. We are grateful for these personal messages and hope they inspired others to their own reflection as to “what generosity looks like.” There are so many ways God can call us to experience and share it.

We offer our gratitude to all of you whose generosity keeps our community thriving!

### **Oasis Women's Group:**

The Oasis Women's study group continues to thrive, primarily meeting on zoom on Wednesday mornings. Alternating between Bible study and related spiritual books, we read/prepare to share discussion on the themes and support each other in our faith lives, often through prayer as requested.

We do meet in person on the first Saturday of the month, 10 AM, just for social fun and welcome any church women to join us. For more information about the group, speak to Judy Blaisdell or Ali Watt.

### **Men's Group:**

The Men's group continues to grow and thrive. Meetings are usually held on the third Saturday of every month. This continues to be a rich and meaningful experience, combining socializing, sharing reflections on the Gospel, and prayer time together. Most recently, the men's group has been studying *Mere Christianity* by C. S. Lewis.

We want to send out a special thanks to the Men's group for their volunteer efforts in the kitchen after Sunday services at various times throughout the year. The entire parish looks forward to their culinary efforts and hospitality. I think we can speak for many of us in the congregation, there's nothing like seeing men in the kitchen.

### **Tuesday Bible Study:**

Open to all and meeting weekly on Tuesdays at 11am in the Dodd Room, this discussion group is led alternately by our magnificent clergy and requires no advance preparation. Focusing on one of the lectionary pieces for the upcoming week, we ponder (wrestle with) the scripture and how it speaks to us, what God's message is. It's a casual yet meaningful way to explore how God is speaking to us! Come and see!

### **Gardens:**

A shout-out to the small but dedicated team of gardeners who strive to create lovely garden spaces around our property. With intentions to establish plants that attract pollinators and bring joy to those who love summer blossoms, they attend to all the watering/weeding needs spring through fall. Ann Malconian, Judy Blaisdell and to Erin Mack who just recently created our new, sweet Peace Garden!

### **Labyrinth:**

Special thanks to Robin Yergeau for renewing interest in our wonderful labyrinth. Under her leadership, a number of us were drawn to participate in several labyrinth walks during the autumn months. Robin's expertise is in using time in the labyrinth in a thoughtful, spiritually rich way. As she frequently says, there is no right or wrong way to walk it. However, her guidance is meant to assist each in creating the way that is most meaningful for them. The labyrinth is a beautifully rich resource for our community. We look forward to the growth of this ministry!

### **Summary:**

As we close out 2025, we are grateful for all of our church family in helping us reach our pledge goals as we enter into 2026. As of this date, 141 parishioners have made pledges, totaling \$404,175 pledges. This has allowed us to not only meet but surpass our \$400,000 goal to reach a balanced budget. Truly, we are a chorus of generosity. We extend our deep gratitude to all of you who volunteer your time, talent, and treasure. Your efforts and faithfulness contribute in so many ways to helping our community thrive!

I have known both Suzanne and Bruce for many years and have had the pleasure of collaborating with them. Bruce is an exceptional organist, a vast source of knowledge, and a dedicated mentor to young organists. Suzanne is a gifted and versatile musician whose strengths include choral conducting, arranging, and piano performance. Christ Church has been richly blessed by their many years of faithful and inspired service, and they have set a high standard that I am honored to follow.

During the early part of the year, Christ Church benefited from the artistry of outstanding substitute organists, including Richard Benefield, Wendy Gladstone, and Mike Cicchetti. As summer arrived, impromptu choirs enhanced worship services on three occasions, while soloists and instrumentalists also enriched our summer offerings. These musicians included Emily Ellis, Patti Andrews, Danielle Larson Clark, Steve Watt, Mike Cicchetti, and Christina DeMaio.

As summer gave way to fall, the faithful Christ Church Choir returned to weekly rehearsals and Sunday services. It has been a joy to become acquainted with the choir members, their voices, and their established repertoire. Together, we have also introduced new anthems that complement the existing music library and further enrich our services. The Advent and Christmas seasons culminated in a moving Christmas Eve service featuring a community choir of approximately thirty singers, an extended prelude with a flute choir, choral anthems, a recorder selection, and a piano four-hands duet.

As we look ahead, I am eager to build upon the momentum of 2025 as we move into 2026. I am mindful of the large shoes I am stepping into, yet I welcome the challenge with enthusiasm and gratitude. My central prayer and guiding focus is that Christ Church will continue to thrive through its established, outstanding music ministry for many years to come.

### **Winter Play, 2025: Junior Cast (Grades 1-6)** ***Once Upon a Crime: The Trial of Goldilocks***

Goldilocks is the defendant on trial for breaking and entering, and the plaintiffs - you guessed it - are the Three Bears. As lawyers Henny Penny and Tom Thumb go toe-to-toe to prove their client's case, other fairytale characters are called to testify as witnesses, including Hansel and Gretel, Jack and his Cow, and Little Red and Granny. Performers rehearsed and performed not one but two different endings, based on whether audiences believed Goldilocks to be innocent or guilty.

### **Winter Play, 2025: Senior Cast (Grades 7-12)** ***The Crucible***

One of the most acclaimed plays in the American theatrical canon, *The Crucible* was penned by Arthur Miller in order to hold a societal mirror up to McCarthyism, and remains a gripping and timely parable of contemporary society. The story focuses on the puritans of Salem, Massachusetts, in particular a farmer named John Proctor, his wife Elizabeth, and their servant-girl Abigail. When Abigail and the girls of Salem maliciously cause Elizabeth's arrest for witchcraft, John brings Abigail to court - and a monstrous course of bigotry, deceit, and mob mentality unfolds.

**Spring Musical, 2025**  
***Hadestown: Teen Edition***

This intriguing and beautiful folk opera delivers a tale that is deeply resonant and defiantly hopeful. Following two intertwining love stories based in Greek mythology - that of young dreamers Orpheus and Eurydice, and that of the immortal king Hades and his lady Persephone - *Hadestown: Teen Edition* invites audiences on a hell-raising journey to the underworld and back. Inspired by traditions of classic American folk music and vintage New Orleans jazz, this modern day folk opera pits industry against nature, doubt against faith, and fear against love.

***Hamlet***

The young Prince of Denmark navigates the treacherous aftermath of his father's death - and his uncle's swift, suspicious rise to the throne. Our adaptation of *Hamlet* invited a new generation of performers to wrestle with questions of revenge, madness, identity, grief, and moral reckoning. With its haunting poetry, flawed characters, and thrilling stakes, this classic drama illuminates the heart of a young man - and a kingdom - truly on the brink.

**Summer Session, 2025**

Our summer theatre workshops are crafted for young performers interested in a fast-paced, supportive, and creative environment led by experienced theatre professionals and educators.

Providing an opportunity to build upon the skills and confidence necessary for success in mainstage productions, our leveled curriculum offers performers training appropriate to their age and ability. In addition to rehearsing a musical to be presented at the culmination of their session, performers take classes intended to expand their skills. Participants leave Summer Session with improved skills in acting, singing, and dancing, a better understanding of the audition and rehearsal process, and the kind of confidence that comes from socializing with like-minded friends while working together to create something to be proud of.

Workshops are held for two-week sessions: Monday through Friday, 9:00 AM – 3:00 PM.

**Building & Grounds Committee (B & G)**

**Introduction and Overview:**

Building & Grounds Committee focuses on annual maintenance activities, building upgrades, future project planning, and long-term building maintenance planning working with the Rector and/or Senior Sexton and reporting to the Vestry. In 2025 the Building & Grounds Committee held two (2) meetings.

**2025 Projects:**

**Courtyard Project:**

This year the Courtyard Project was completed early June of 2025. B & G Planning of this project started in 2019. We now have new concrete walkways and platforms connecting the

three entrances (Narthex, Harris Hall, and Vestibule Entrances) with two automatic door openers for the Narthex and Vestibule door entrances making the Church and Harris Hall accessible for ALL. Perimeter garden areas have been updated including increase in stone area to drain rainwater and snow melt from roof runoff. See attached pictures for more information.

A special thanks to Steve Watt for developing (and making changes along the way) the Architectural drawings of the Courtyard Project and Mike Yergeau Sr. for Project Managing the start and completion of this project including changes as needed during construction. His work included many pictures during construction along with before and after pictures.

We wish to thank our principal benefactor, The Bauman Family Foundation. The General Contractor was CUSA Consulting LLC, Hampton, NH. Mark Thurston, President and Jared Blais was our main contact. Below you see before and after.



#### **Lightning Protection System:**

During the renovation of Harris Hall (2016-2018) the Lightning Protection System was disrupted. This was restored to protect Harris Hall, Church and Chapel. A Lightning Surge Device is scheduled to be installed on the Main Circuit Breaker Panel ASAP.

#### **Outside Stage Platform and Ramps:**

Preparation (cleaning and sanding) and applying one coat of transparent stain to protect the Outside Stage Wood Platform and Ramps was performed in October 2025. This took four days to complete.

#### **Roofing Over Vestibule Roof and Miscellaneous Items:**

#### **Work was performed on Vestibule roof area that included:**

Correct delaminating perimeter edge flashing.

Install tapered insulation cricket above Flue Chase Structure.

Repairs to lower roof including new flashing at base and corners of the built-up Flue Chase structure. Thirty-two feet of snow fence on Harris Hall Roof at overhang/soffit to protect from sliding snow on to the vestibule roof, Flue Chase Structure and Sloped Metal Roof Cover to Vestibule Entrance.

#### **Other Misc items:**

##### **Cap Shingles on the church roof on the Pine Street Side.**

Work was performed in November 2025.

#### **2026 Projects:**

OneLine drawings of the Electrical Power Distribution System for Harris Hall, Church and Chapel. This is a safety related item in the event of down circuit(s) and/or future demand.

OneLine drawings of the "Heating System" that includes the Boilers and Zonal Hot Water Distribution piping/pumps that heat Harris Hall, Church, and Chapel. This is a functional related item in the event that there is a disruption in the heating system, and we need to identify problem areas along with managing/maintenance of the heating system.

#### **2025 Heating Systems:**

In early November the heat exchanger on one of the two boilers cracked disrupting the heating to all buildings. Couple with this, pumps to the Narthex and Common Room and Archive rooms were not working and/or down. Since then, a new boiler has been installed and pumps for down zones have been and/or will be installed within the next two weeks.

In 2025 B & G has been working on upgrades to the zonal pumps and piping with Palmer & Sicard (newly contracted) as needed to maintain our heating and cooling systems.

Long term finance planning to replace MEP equipment and building maintenance projects continues by the Vestry for future and maintenance projects.

- Church Ceiling Plaster and Painting (Maintenance)
- Cleaning and Painting Church Eves (Maintenance)
  - Church Roofs (Maintenance - Asphalt Shingles)

### **Report of The Endowment Board 2025 and the Anchor Legacy Society**

*The Minister of the Congregation is directed to instruct the people, from time to time, about the duty of Christian parents to make prudent provision for the well-being of their families, and of all persons to make wills, while they are in health, arranging for the disposal of their temporal goods, not neglecting, if they are able, to leave bequests for religious and charitable uses. (Page 445 in the Book of Common Prayer)*

In December 2014, the Vestry of Christ Church created a new Endowment Fund and set proper gift acceptance and spending policies. The income from this new Endowment Fund is limited to capital improvements, developing new ministries, outreach ministries and special projects.

As of December 2025, the balance of the fund was **\$375,164.**

On All Saints' Day each year, we recognize those who joined the Anchor Legacy Society by remembering Christ Church in their wills or making provision for the church through other planned gifts. In 2025 we recognized ***In Memoriam Nancy Alcock-Hood***, who died in 2024. We received a generous bequest from her estate.

If you are making a will or updating financial or estate plans and you would like to support God's work in Exeter and the wider church and community, please reach out to us for more information so that we can answer any inquiries you may have. In addition, we take this opportunity to remind parishioners that the Endowment Fund welcomes gifts for any occasion; it is not exclusively for bequests. Gifts in memory of a family member or friend are very appropriate; likewise, gifts in honor or in celebration of a person or event are equally desired. There are any number of occasions when a gift can be made, (birthdays, baptisms, graduations, anniversaries, good fortune, and others) recognizing the moment and helping to grow the Fund.

### **Report of Higgins Fund 2025**

The Higgins Fund was established by Christ Church members John F. Higgins and Jeanne G. Higgins in 1978 to minister to the spiritual, mental, and physical needs of the elderly and infirm; to supply clergy, aides, teachers, social workers, or others to assist in their well-being; and to aid the indigent who may need monetary assistance at home or in health care institutions on the Seacoast.

As currently directed by the Trustees of the Fund, an individual may receive no more than \$1000 during one calendar year from the Fund.

During 2025, \$2060 was distributed to eligible applicants.

As of December 31, 2025: \$3210 is held in cash reserves. \$22,234 remains invested with the Diocese.

### **Our Companion Parish Relationship with *San Francisco de Asís* in Cardenas, Cuba**

We were not able to send a group to Cuba this past year, but my wife Leslie and I traveled in February through Mexico City to deliver medicines and food funded and donated by church members.

I attended the consecration of the new Cuban Bishop, the Rev. Angel Rivera of Puerto Rico, in September, again bringing medicine and donations.

The recent U.S. military operation in Venezuela has brought even more uncertainty with regards to Cuba's stability and the future of the Regime. We have a trip scheduled for March 2026 God willing to bring water systems and more donations.

Christ Church members contributed to Christmas and Easter meals that fed many in Cardenas.

### **Treasurer's Report**

The year 2025 was a good one financially for Christ Church. That is the result of your generous support of the mission and community we share here. We have been able to meet unexpected challenges. Repairs to our heating system early in the year and replacing a boiler during the coldest December in recent years would be an example. We have also been able to support a parish life that continues to recover post-Covid, expanding church school offerings and supporting family focused activities like children's chapel. Our music program is thriving. We are doing good in the community through Seacoast Family Promise, our holiday food and gift baskets, supporting Mark's work with those in prison. And always looking south to Cuba as their friend in difficult times. This is possible because we have welcomed new and generous givers, both pledged and unpledged, as members of the parish. We have also benefited from former parishioners who have passed on and left significant gifts that are being added to our endowment.

We finished the year with a \$77,000 surplus. We will dig into that surplus to pay for the new boiler and some expected additional repairs that came to light with the recent heating and water issues in the chapel and narthex.

Income was over budget by \$211,000. This is thanks to several generous one time gifts, a significant bequest, and gifts in memory of departed parishioners. 2025 income does not include nearly \$19,000 of 2026 pledges that were prepaid in 2025. Those will be recognized during the course of 2026 and the cash will be invested in a high yielding money fund.

Expenses were generally in line with the budget. The exception was the transfer of a large bequest to the endowment fund, which shows as an expense. We did fund the clergy sabbatical reserve. It does not show as an expense since it was included in a bulk transfer that captured all additions to our bank reserves at year end.

Pine Street Players deserve a special mention here. The net surplus from PSP activities in 2025 was nearly \$6,000. We will make equal additions to both the PSP and Christ Church cash reserve balances from this surplus. While that makes for a great year in its own right, what is more significant is that PSP deferred nearly \$40,000 of 2026 income that was collected in December. This is the first year that revenue during the calendar year activity was adequate to create a surplus without using the pre payments they always receive in December. Like the parish's prepaid pledges this revenue will be recognized ratably during 2026.

The best way to think of both our parish prepaid pledges and PSP's deferred revenue is that they give us a head start on our financial status for 2026.

Our balance sheet remains strong. We have adequate and ample cash, including reserves of \$120,000. The balances of the endowment funds are as of September 30 2025 as I write this report. When we receive the final year end numbers they will be higher to reflect both the addition of the bequest and investment results for the fourth quarter.

You will notice that the endowment balances are now presented in three categories - unrestricted, donor restricted, and vestry designated. This was done in consultation with our CPA firm and is a more appropriate way to present these balances. We will be consolidating many of the small balance unrestricted funds into a new fund that will be named the Founders Legacy Fund. Two garden funds that have similar purposes will be combined and the Reserve Fund will be consolidated with the Endowment Fund since they have identical purposes.

We have finally been able to engage a CPA firm to review our books and records. Nesseralla and Company will do that work in April and May.

I want to thank Jason Mignone who has partnered with me in keeping our financial records this year. We are blessed to have his conscientious service.

Allow me to end as I began. This has been an easy report to write thanks to your generous support of our life together. Thank you for your part in making Christ Church a vibrant and caring community. It is a privilege to serve as your treasurer.

## **2026 Budget Comments**

Richard Ingram

The Budget for 2026 approved by the vestry follows closely that of 2025. It includes 3% increases in compensation for staff. It also reflects a full year of Adam Peithmann sharing his music gifts with us and Katie Mize bringing her love of teaching to our church school.

There will be a small increase in our endowment income in 2026 and pledge income is budgeted for what we know as of January 11. Unpledged donations have been very generous the past few years. We have budgeted \$40,000 for 2026, which is conservative based on past history but is also a significant assumption. Loose plate has been budgeted fairly conservatively. Support from the Diocese for Nicole's position is being reduced. That is according to plan as the Diocese looks to share the funds available for assisting priests with other parishes.

We have reduced the budgeted expense for furnace maintenance. We invested quite a bit in new parts and a boiler in 2025, so that seems prudent. Most other expenses are pretty much in line with 2025. Our Fair Share payments to the Diocese will go up. The budget includes an estimate but we won't know the actual new amount until April.

I pray for our continued financial strength and thank you for your part in it.
